2		Minutes of May 21, 2024, were tabled. Motion #141 Ed Dyke/Agatha Stack Balsom
		Proposed to accept minutes of May 21, 2024. All in favor, motion carried.

3		#6 Councillor Dyke, the town foreman and the CAO met to discuss the asphalt
		repairs for 2024. There were two sections in Maddox Cove and a larger section on
		Southside Road. Councillor Dyke noted that one company has given council a really
		good price as they will be in the area doing other work for the town. Staff is still waiting on two more quotes for this work.
4		#8 Councillor Balsom noted that parking on Southside Road over the weekend was
		really bad. He suggested that the town get in touch with the Carton Loft operators
		and inform them that their clients are parking on the road and not in designated

		direction of the road. Notices were sent out to residents on Main Road Lane for comment about this request. The town received two letters and they were tabled.
		Mr. Leo Hearn was present in chambers to speak. Mr. Hearn noted that the traffic on
		this lane is a major concern. He stated that traffic is pulling off the Main Road onto
		the lane at high speeds. He noted that children are in the area and it is very
		dangerous. He asked if council could change the direction of the one way or make it a "No Zone". Councillor Balsom asked what the visibility would be like exiting
		onto the Main Road if the direction was changed. Mr. Hearn stated that he felt that it
		wouldn't be a problem as people would have to stop at the stop sign before exiting
		onto the Main Road. Deputy Mayor Raymond noted that if the direction was
1		changed it should reduce traffic in the area. Motion #142 Ed Dyke/Rick Raymond
		Proposed to change the direction of the one-way street on Main Road Lane and to
		add a "Wrong Way" sign at the beginning of the road off Main Road. Staff will also
